# CURRICULUM, INSTRUCTION, AND ASSESSMENT

- I attended "The Legal Rights of Students & Parents" webinar presented by the Illinois Principal Association on June 12th to learn the updates for 2019-2020 school year.
  - o The Basic Skills Test for teachers has been eliminated in hopes to help with the teacher shortage.
  - o In accordance with ESSA and P.A. 100-156, chronic absenteeism occurs when a student is absent for 10% or more from the school year. This includes both excused and unexcused absences.
- The 2018 KIDS (Kindergarten Individual Development Survey) data will be released to the public on June 25th. We had 100% participation rate, and the percentage rate of our Kindergarten students' readiness compared to the state average in the three developmental areas are as follows:
  - 82% EES
     77% EES
     46% IL
     Social and Emotional Development
     Language and Literacy Development
  - o 77% EES 33% IL Math Cognition

# CURRICULUM, INSTRUCTION, AND ASSESSMENT

- SAT results are in and initial results look even better than last year. Average score is a 1067 (21 ACT)- ELA 535 and Math 533
- PSAT for grades 9 and 10 show that we have some teaching to do:
  - o Grade 9 average score of 923- ELA 467 and Math 455
  - o Grade 10 average score of 996- ELA 515 and Math 481
- May 24th last day teacher in-service meetings were well received by the staff. We had great conversations about planning for next year's students, documenting the learning standards, and making changes to our final exams.

### **WORKSHOPS**

- I attended a workshop put on by the Illinois Principals Association to help with analyzing our SAT assessment data. It was time well spent and I have some great ideas for sharing the information with the entire staff. Department time will be used to analyze group and individual data.
- June 7th- attended ICC to work on our PACE framework. We have to have our framework in place by the start of the 2020 school year but feel confident that our students and staff will start inputting information this year.

## **ACTIVITIES/FACILITY**

- Athletic camps and workouts have kept the school a busy place.
- Summer maintenance and cleaning is progressing nicely. Joe and his crew have completed the JH, 75% of the HS, and 50% of the GS.
- Check out the JH lockers and the concrete work behind the concession stand. I'm pleased with how the summer projects are proceeding.
